# Course Description:

This course focuses on the causes, course, and implications of the Arab-Israeli conflict from World War I to the present. It examines the history of the conflict, comparing the conflicting narratives of the Palestinians, the Arab States, and Israel. It explores the politics of force over the course of the conflict, as well as the diplomacy of the conflict. It examines the relationships among Arabs and Israelis, as well as inter-Arab relations and the relations between the rivals and external powers. The course offers a window into the interrelations between domestic forces—political, economic, social—and the international relations of Israel and the Arabs. Finally, it examines the ramifications of the conflict for the rivals and for the international system writ large. Topics covered in the course include the following:

- Inter-Arab politics and the Palestinians, 1949-1967
- The Six Day War and its aftermath: Israeli policy in the occupied territory

- The rise of the peace process—from step-by-step diplomacy to the Egyptian-Israeli peace treaty
- The Lebanon War
- The First Intifada
- The Gulf War and the Madrid Process

- The collapse of the Oslo Process and the Al Aqsa Intifada
- Israeli unilateralism in the occupied territories
- Palestinian politics during the Intifada
